Example: Individual trustee. On 29 June, an individual trustee writes a note, dated 29 June, stating that they have resolved to distribute the trust income in a certain way. On 15 July, the trustee types the note reflecting the resolution of 29 June and provides a copy to the beneficiaries.

Consider using something like 0001 and then giving all future resolutions a consecutive number. Form a title of the resolution that speaks to the issue that you want to document.

The Act sets out the type of resolution required for specific actions. Ordinary resolutions can be made at an annual general meeting (AGM). For example, to approve the budget requires an ordinary resolution. Electing trustees also requires an ordinary resolution.
